

## World Triathlon Paratriathlon Athlete Evaluation Consent Form

I agree to undergo the Athlete Evaluation process detailed in World Triathlon Paratriathlon Classification Rules and Regulations and administered by a designated World Triathlon Paratriathlon Classification Panel. I understand that this process may require me to participate in sport-like exercises and activities which may include me being observed whilst competing. I understand that there is a risk of injury in participating in exercises and activities. I confirm that that I am healthy enough to participate in Athlete Evaluation and to swim, bike and run.

1. I understand that I have to comply with the requests made by the Classification Panel. This includes providing sufficient documentation so as to allow a Classification Panel to determine whether I comply with the eligibility requirements for World Triathlon Paratriathlon I understand that if I fail to comply with any such request then Athlete Evaluation may be suspended without a Sport Class being allocated to me.
2. I understand that Athlete Evaluation requires me to give my best effort, and that any Intentional Misrepresentation of my skills, abilities and/ or the degree of my Impairment during Athlete Evaluation may result in me facing disciplinary action (see World Triathlon Intentional Misrepresentation Rules in the Classification Rules and Regulations handbook).
3. I understand that if I experience pain during the Athlete Evaluation I have the option to continue regardless of pain or discontinue the evaluation, the later resulting in a withdrawal from the event.
4. I understand that Athlete Evaluation is a judgment process and I agree to abide by the judgment of the Classification Panel. If I do not agree with the decision of the Classification Panel, I agree to abide by the Protest process as defined in World Triathlon Classification Regulations.
5. I agree to be filmed and photographed during the Athlete Evaluation process and that this may include my activity on and off the field of play during any World Triathlon Competition. This material may be used for any classification evaluation process done by World Triathlon in which I am involved.

### **DATA POLICY**

6. Pursuant to the applicable law and the International Standard for the Protection of Privacy and Personal Information ("ISPPPI"), I agree and consent to World Triathlon collecting, storing or recording my personal data in any format such as but not limited to: full name, gender, country, date of birth, training and competition background with the purpose to complete the Athlete Evaluation process of classification. This information shall be maintained secured and in strict confidence at all times by World Triathlon in the designated office and with access by the authorised designated person.
7. Pursuant to the applicable law and the International Standard for the Protection of Privacy and Personal Information ("ISPPPI"), I also agree and consent World Triathlon to collect my medical diagnostic form and all medical related information provided by me, to store that information and be retained by World Triathlon. This information shall be maintained secured and in strict confidence at all times. This information shall be used exclusively for the purpose of the Athlete Evaluation process of classification. This information shall be maintained secured and in strict confidence at all times by World Triathlon in the designated office and with access by the authorised designated person.
8. At the conclusion of the Athlete Evaluation Process, I agree for World Triathlon to publish the associated information from the outcome of the classification process such as my personal data and my Sport Class, Sport Class Status, Year of classification in order to update Classification Results at the competition venue and on World Triathlon Classification Master List on World Triathlon Website. I agree for this information to be shared with third parties such as Local Competition Organisers.
9. All the information collected by World Triathlon for Athlete Evaluation Process, production of Classification outcomes, Research and investigation or Educational purposes, will only be used for as long as it is needed and has validity for the Classification System.
10. All information collected by World Triathlon for classification purposes, will only be stored as long as the information is valid and related to the existing classification system. Once it has no relation with the existing classification system, World Triathlon will destroy all related information in storage.
