	Question about the document drafted by Johan.
Discussion about the rules of the Congress Procedure	Any questions or proposal about the document shared by Johan.
	 Goal is to present a final draft to the EB meeting in April. The Legal and Constitution Committee has the approve a final draft and after present it to the EB.
	• The information in the Rules for Congress Procedure has to be exactly the same as the one in the Constitution (the constitution will always prevail).
	The purpose of the creation of the document of the procedure during Congress is
	 to summarise and help the Members to memorise the procedure during Congress without consulting all the articles of the Constitution (for example, how to run election during the Congress). To fix the rules during a Congress meeting in replacement of the Robert Rules of Order (669 pages).
	• One of the points raised during the call is the number of pages of the document (19 pages). It is too long to be considered as a summary (it has to reduced).
	 Discussion with everybody in the committee about the rule "discussion of the resolution.
	 Discussion about the Voting Majority (page 12 of the document studied).
	 Discussion about the right to speak at the Congress for the candidate of an election: nothing is specified in the Constitution.
	There were no changes in the constitution since last year about that provision. The provision should be clarified for more consistency.
	 Johan suggests to prepare a rule for the speech of candidate of election at Congress. Bernard and Gale agreed too. The candidates cannot speak, but







	according to the Constitution, have personal record, goals presented to the Delegates: what they want to achieve.
	 Will be discussed later, and won't be presented to the Executive Board in April. Johan will circulate a new draft later. Antonio suggests: during the Executive Board to approve a working group for the question of the World Triathlon Licence, included the following country: USA, Australia, Asia (Japan or China), France and Belgium, Mexico and one country from Africa continent (Tunisia).
