- ITU Development Grant is to develop our sport within the territories of each member National Federation and to support functioning of the Continental Confederations.
- Maximum of 20% of the total continental grant can be spent on Administration Management & Governance as per ITU recommendation.
- The Annual Continental Development Planning based on the needs of the National Federations and the Continental Confederations aligned with the ITU Strategic Plan.
- The Continental Development plan should be submitted (until 1st of November), discussed and finalized with ITU and approved by both: the respective Continental Executive Board and the ITU Executive Board.

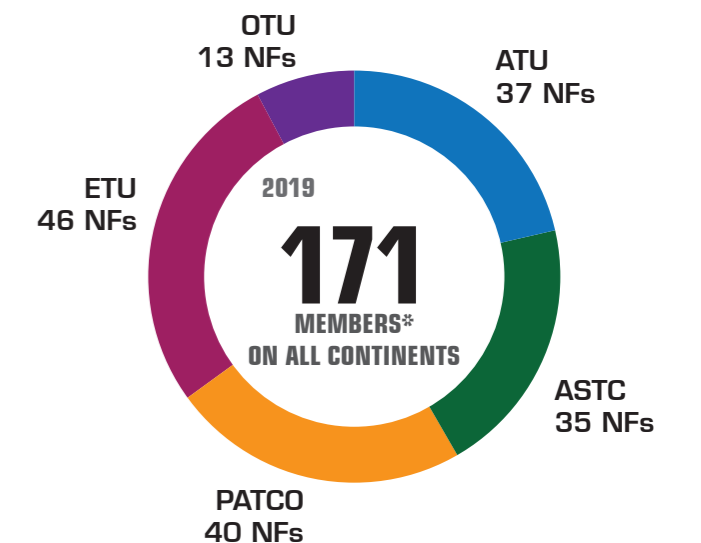

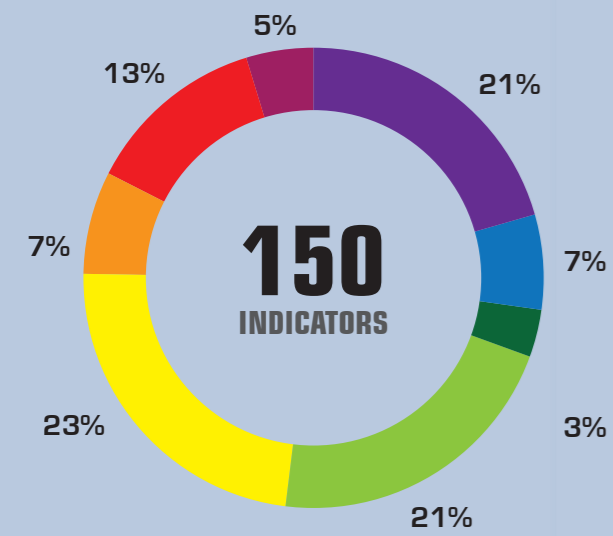
MEMBER NATIONAL FEDERATIONS OF THE INTERNATIONAL TRIATHLON UNION



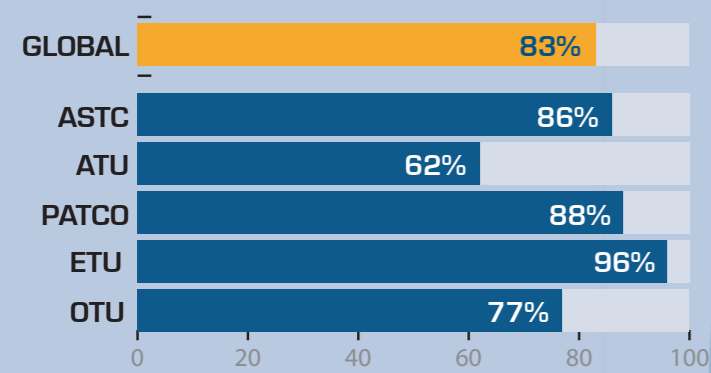

ITU WORLD TRIATHLON NATIONAL FEDERATION SURVEY 2018

- Piloted in 2017
- Updated scoring system KPIs
- Survey in **two formats**: online and excel
- **Gender equity** added to the main areas
- **Two methods of data collection**
 1. ITU National Federation Survey in 3 languages (English, Spanish, French) - online/offline versions
 2. ITU Data Collection from various ITU databases and the backend (Technical Officials, coaches, facilitators, paratriathlon classifiers, events, results, etc.)
- **150 indicators**
88 (58,7%) survey-based and further 62 (41,3%) historical indicators in 8 main areas:



- **National Federation PARTICIPATION**
As of now ITU has 171 affiliated National Federations on the five continents. In case of ETU Andorra, Bosnia and Herzegovina and Gibraltar are special NFs as they are not affiliated to their respective Continental Confederation.

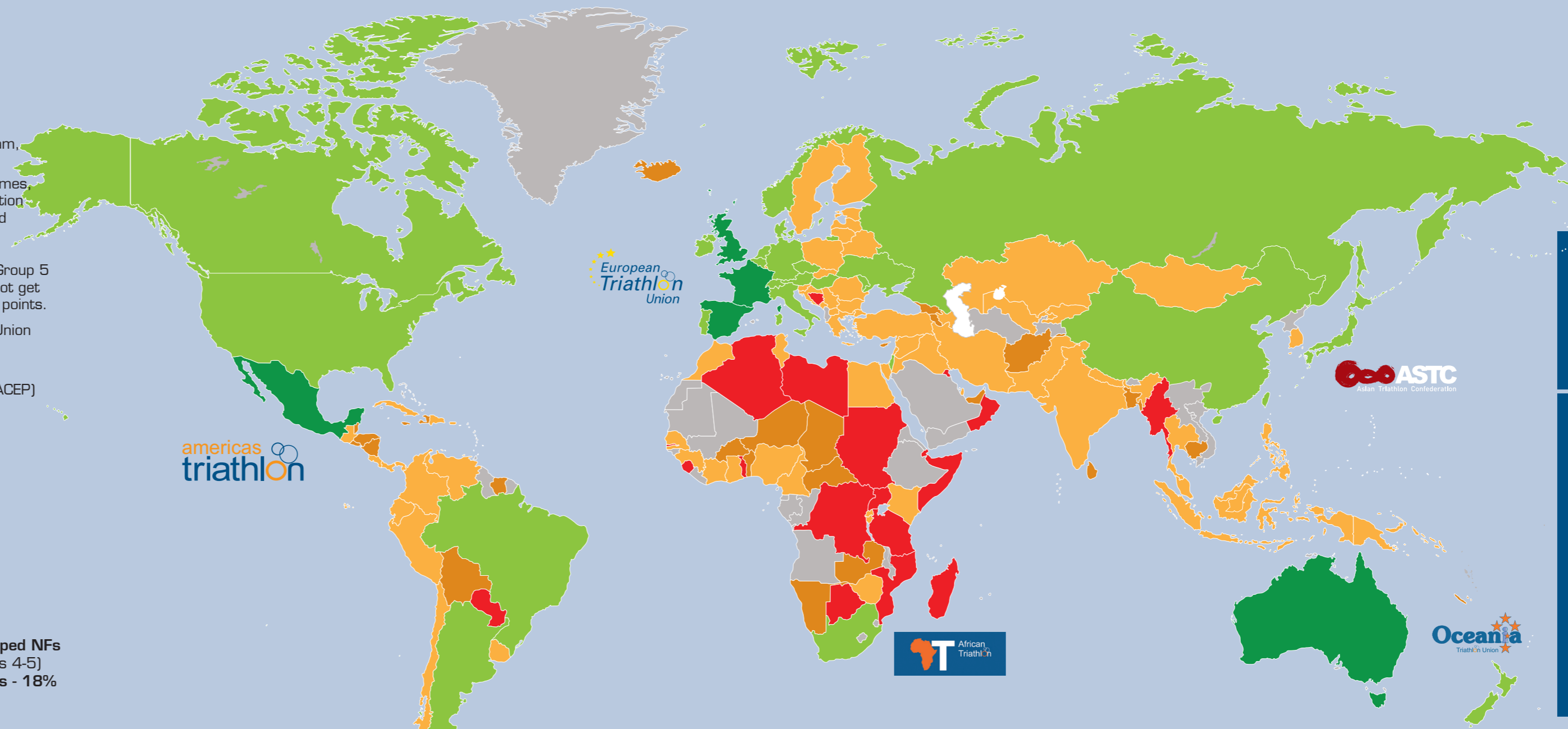
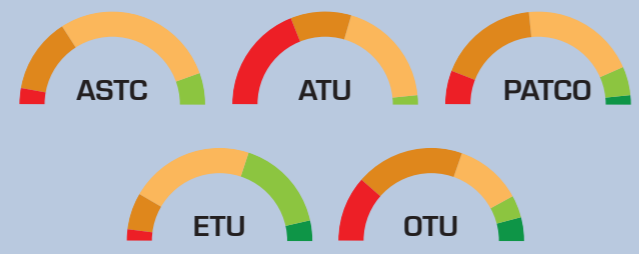
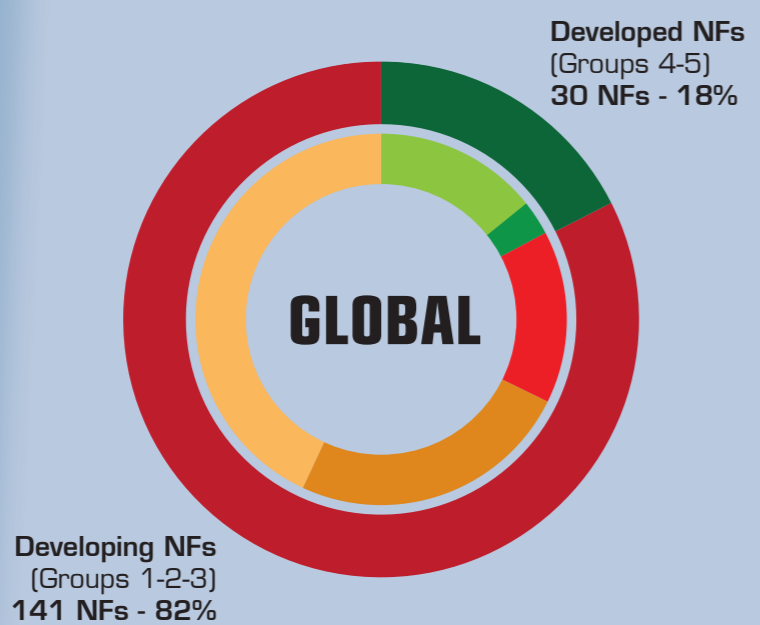


- **National Federation GROUPS**
 - 1 Established National Federations (NFs)
 - 2 Established and functioning NFs
 - 3 Well established and functioning NF with Development Programs, Youth and Junior Continental Event participation
 - 4 Developed NF, Structured Education Program, Continental Class Athletes in all ages
 - 5 Developed with High Performance Programmes, World Class Athletes, ITU Accredited Education Systems, High Gender Equity, ITU Sanctioned Event Hosting

The below KPIs are strict requirements to achieve Group 5 ranking. If any of these KPIs is missed, the NF cannot get Group 5 recognition regardless the total number of points.

- In good standing with the International Triathlon Union (ITU)
- Minimum 20 % of female EB members
- ITU Accredited Coaches Education Programme (ACEP)
- ITU Accredited NF Technical Officials Education Programme (ATOEP)
- At least one continental or world class event's development

RESULTS OF THE 2018 NF SURVEY



The ITU World Triathlon National Federation Survey 2019 will be launched in early January 2020.

Submission deadline is 10 February 2020.

- REMINDER**
- Non-responding NFs are not eligible to apply for or/and attend any development projects until the National Federation Survey completion/submission to ITU, as approved by ITU EB.
 - Non-responding NFs are not eligible to host any ITU/continental sanctioned event until the National Federation Survey completion/submission to ITU, as approved by ITU EB.

OBSERVATIONS

- Annual follow-up of the Survey shall increase objectivity.
- Missing answers or misinterpreted questions that should be addressed
- Remarkable gaps between continents
- Further and continuous research, analysis and discussions
- NFs between category 3 & 4 require further investigation
- Participation (83,04 % on a global scale) has been increased
- Non-responding NFs (29) in 3 categories:
 - Non-existing/non-active,
 - Under reestablishment/re-affiliation
 - Responding without final submission

SHORT-TERM STEPS (by end of 2019)

- Individual Feedback & NF assessment to be sent to all NFs, copying CC's President (DONE)
- Publish and share the ITU National Federation Survey and its results by the ITU Congress in Lausanne (DONE)
- NF group to be added to the NF profile on triathlon.org (DONE)
- Update and optimize the list and the weight of indicators (IN PROGRESS)
- Further investigation in the status of the non-responding NFs (IN PROGRESS)
- Face-To-Face Meetings with the participation of the Continental Confederations to be set up with all NFs (IN PROGRESS)
- Develop a user-friendly survey (IN PROGRESS)

MEDIUM-TERM STEPS (by end of 2021)

- Yearly data collection
- Random checks on submitted surveys of the National Federations
- Launch the ITU National Federation Development Ranking
- Launch the National Federation Development Profile
- Consider and implement the outcomes of the ITU National Federation Survey (Rio Olympic Cycle vs Tokyo Olympic Cycle) in the next ITU Strategic Planning (2022-2025)

RECOMMENDATIONS

- To be considered as Annual Report
- Discuss possibilities of reducing duplicated questions, questionnaires at ITU and Continental level
- Consider the current Survey in the ITU Development grant distribution to the Continental Confederations and National Federations for 2020
- Only Group 1-2-3 NFs are eligible to get development support from the ITU Development Grant
- The ITU National Federation Survey must apply to ALL Continental Confederations
- National Federations' statuses (Affiliation vs Good Standing) must be strictly monitored by ITU and Continents
- After completed revision of affiliation status of the National Federations update the membership status of the NFs as per ITU constitution
- NF should have the opportunity to use this analysis as a tool to orientate their own resources to develop triathlon in a more effective way within their own territories
